CALL FOR APPLICATIONS FOR THE FILLING OF ONE POSITION OF CUSTODIAN RESPONSIBLE FOR MUSEUM GALLERY SUPERVISION AT THE HELLENIC INSTITUTE OF BYZANTINE AND POST-BYZANTINE STUDIES IN VENICE

The Hellenic Institute of Byzantine and Post-Byzantine Studies in Venice hereby announces a selection procedure for the filling of one (1) position of Custodian responsible for museum gallery supervision, under a fixed-term private-law employment contract, part-time, consisting of sixteen (16) hours per week, with work scheduled on Saturdays and Sundays. The contract shall have a duration of one (1) year and shall be governed by the Italian National Collective Labour Agreement for the Commerce Sector (Level 4), pursuant to Article 6(1)(c) of Law No. 4505/2017.

A. REQUIRED QUALIFICATIONS

1. High school diploma or equivalent qualification.
2. Permanent residence in Venice or within the territory of the Veneto Region.
3. Excellent knowledge of the Greek and Italian languages.
4. Good knowledge of the English language.
5. Age between 21 and 60 years at the closing date for submission of applications.
6. For male candidates of Greek nationality: fulfilment of military service obligations or lawful exemption from such obligations.

Experience in similar duties will be considered an additional qualification.

B. SUBMISSION OF APPLICATIONS

Interested candidates are invited to submit an application, accompanied by the required supporting documents, no later than Friday, 6 March 2026.

The application must be accompanied by the following documents:

1. Curriculum vitae.
2. Copy of passport or national identity card.
3. Copy of the high school diploma and, where required, official recognition of equivalence of the qualification.
4. Copies of certificates attesting knowledge of foreign languages.
5. Copy of a certificate of permanent residence or registration with the municipal registry (Anagrafe) of Venice or of another Municipality within the Veneto Region.
6. Copies of documents proving professional experience (if any).
7. Copy of certificate of fulfilment of military service obligations or lawful exemption (only for male candidates of Greek nationality).

The selected candidate shall, in addition and regardless of the deadline set for the submission of the other required documents under this Call, submit a Criminal Record Certificate issued by the country of permanent residence, namely Italy, and by Greece, if it appears that he/she has resided there in the past.

Candidates meeting the required qualifications will be invited in due course to attend an interview at the Institute's premises.
